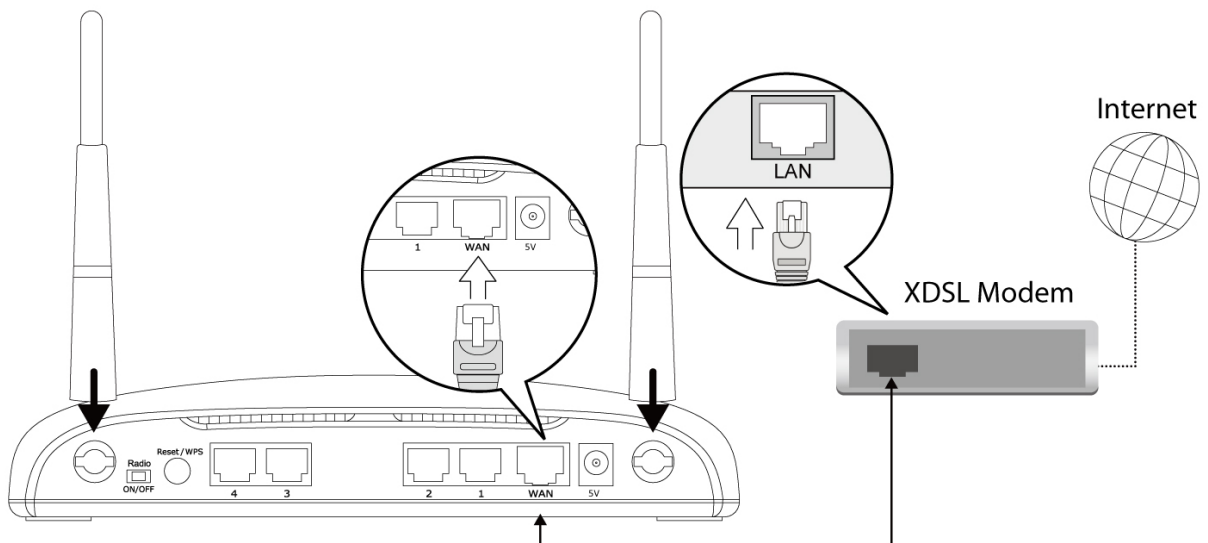

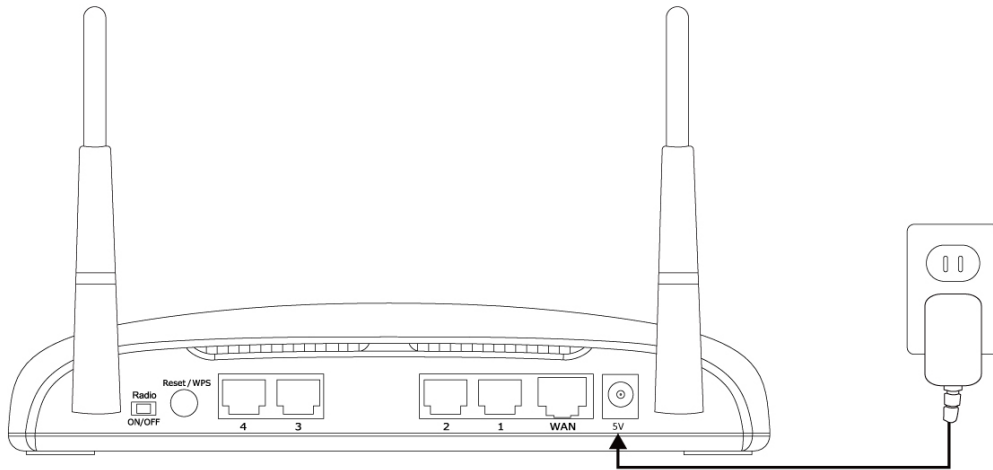

# Installation

**1.** Use an Ethernet cable to connect the router's **WAN** port to your modem's **LAN** port.



2. Plug the included power adapter into the router's 5V DC power port and the other end into an electrical socket.



3. Ensure that the “Wi-Fi On/Off” switch is set to **On** and that the power LED and WAN LED are lit. If not, the router is not properly connected.



4. Use a Wi-Fi device (e.g. computer, tablet, smartphone) to search for a Wi-Fi network with the SSID “edimax.setup” and connect to it.

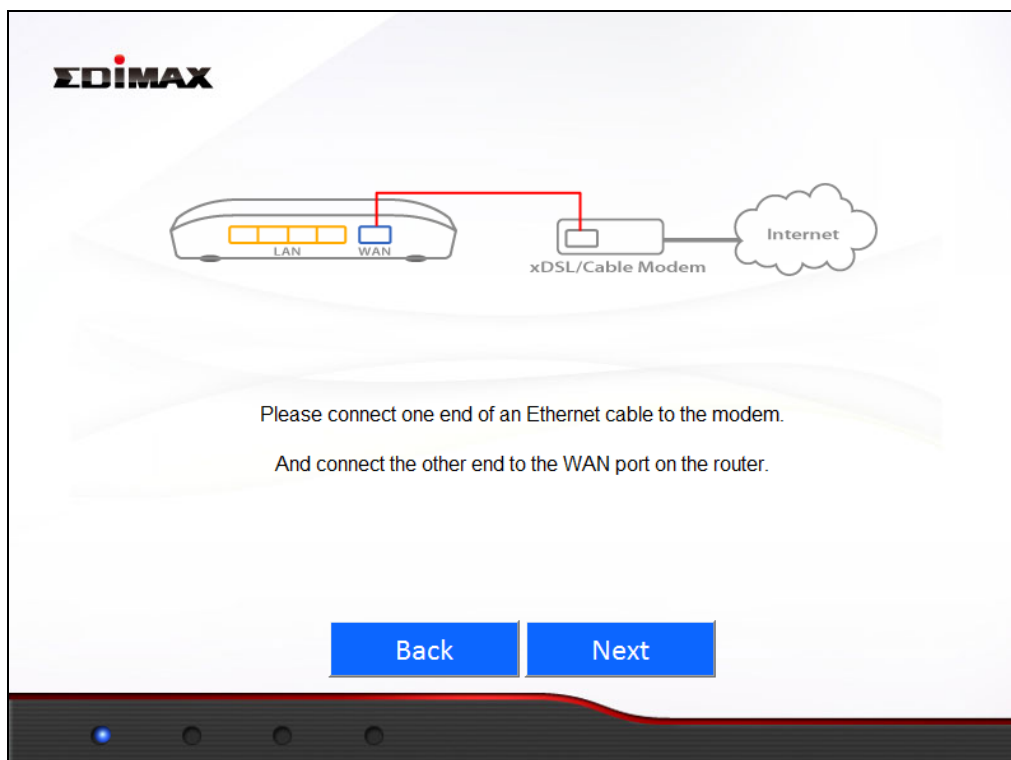
5. Open a web browser and if you do not automatically arrive at the “Get Started” screen shown below, enter the URL <http://edimax.setup>. Select your language from the drop down menu and click “Get Started” to begin the setup process.



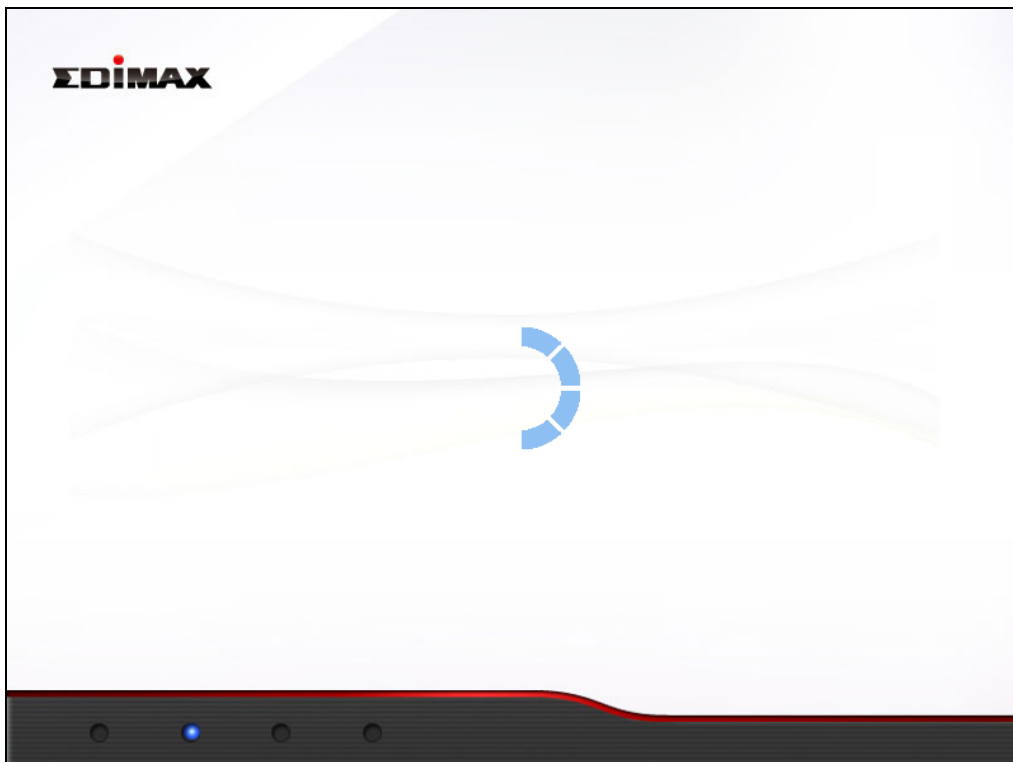


**Note:** If you cannot access <http://edimax.setup>, please make sure your computer is set to use a dynamic IP address. This is a simple procedure, and step by step instructions for how to do this can be found in the user manual.


6. Ensure that your router is properly connected to your modem as shown on the screen, and click “Next” to continue.

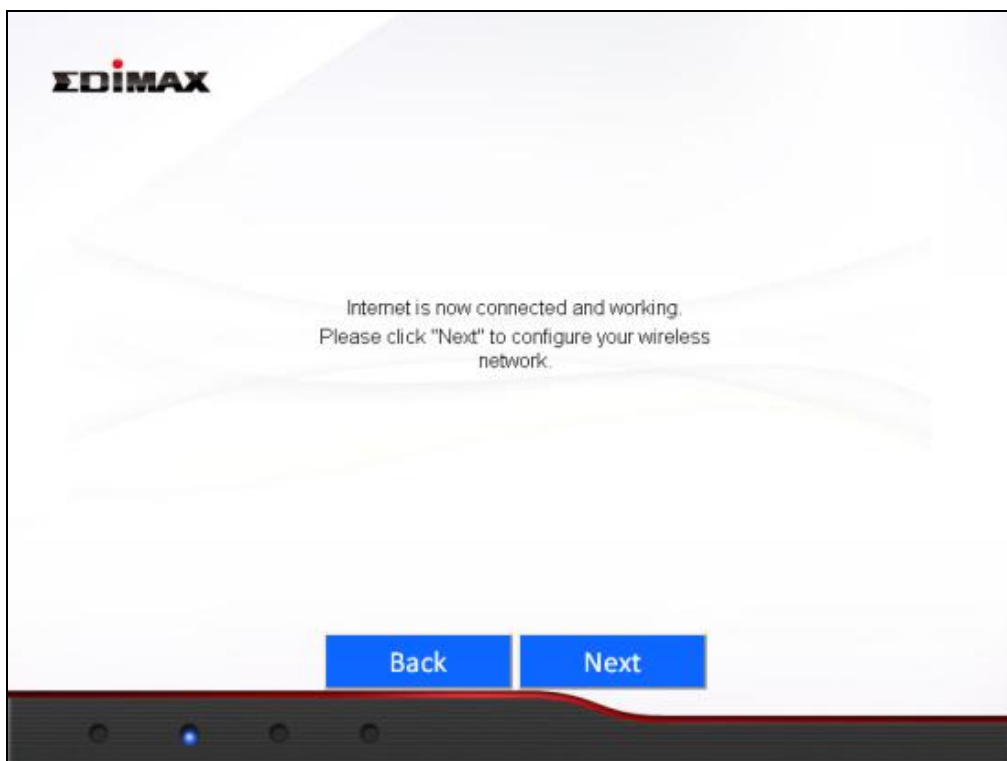



7. Please wait a moment while the BR-6478AC detects your WAN connection type.





8. The BR-6478AC will display the next screen depending on your WAN connection type.

 For **PPPoE** users please enter the username and password provided by your ISP and click **“Next”** to continue:





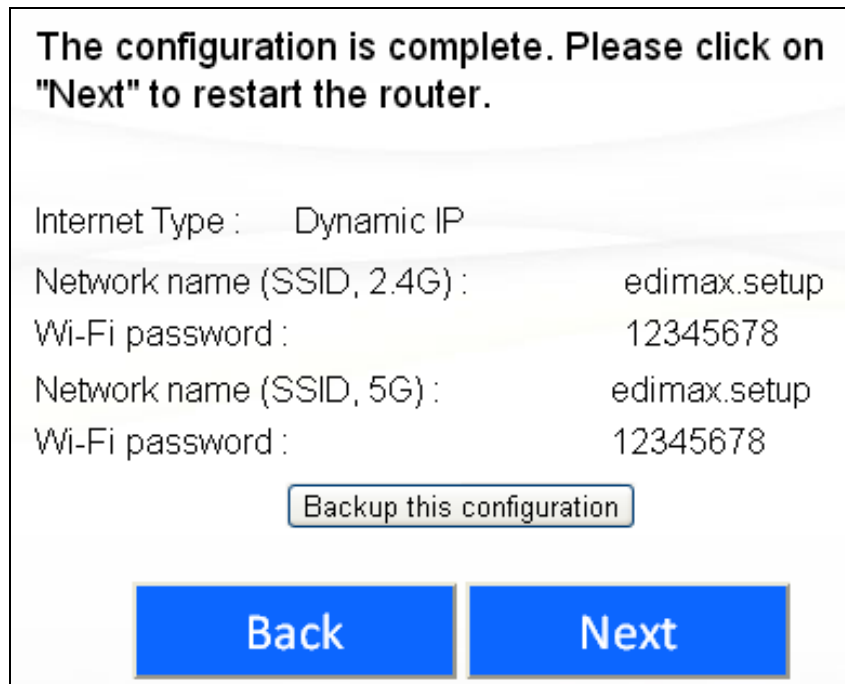

**Note:** Please remember these details. For your convenience, you can write them down at the end of this QIG in **"Wi-Fi Settings"**.

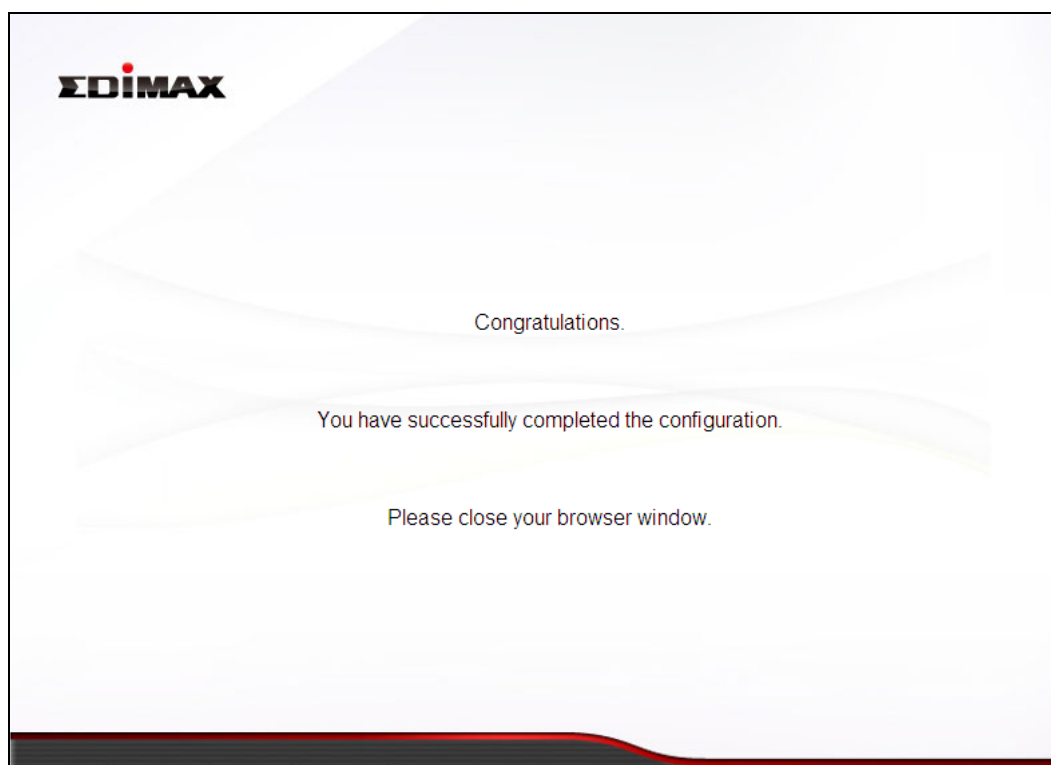

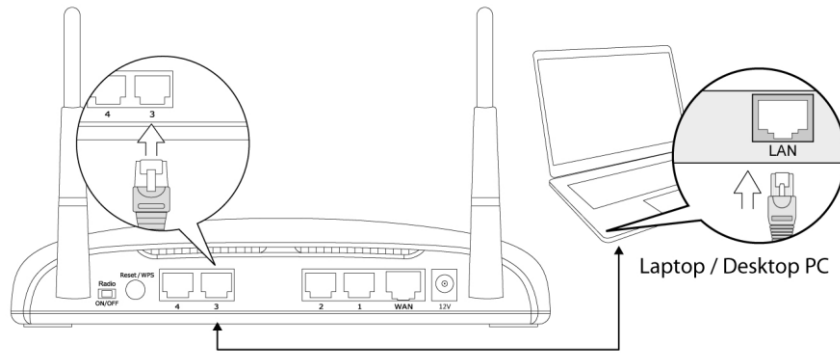

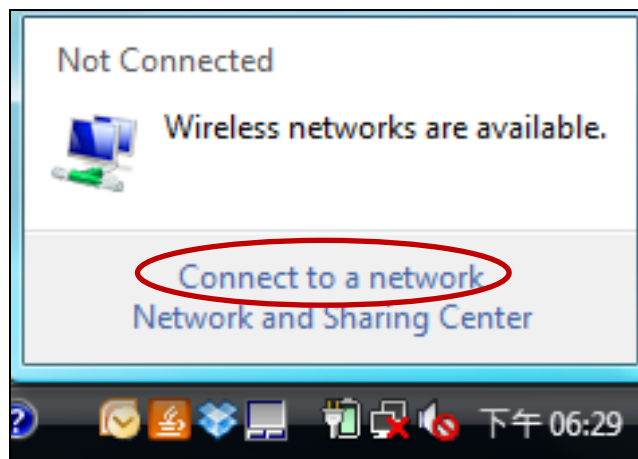


**13.** You can now use a Wi-Fi device to connect to the BR-6478AC's wireless networks.

### Windows

Click the network icon ( , , or  ) in the system tray and select “**Connect to a network**”.



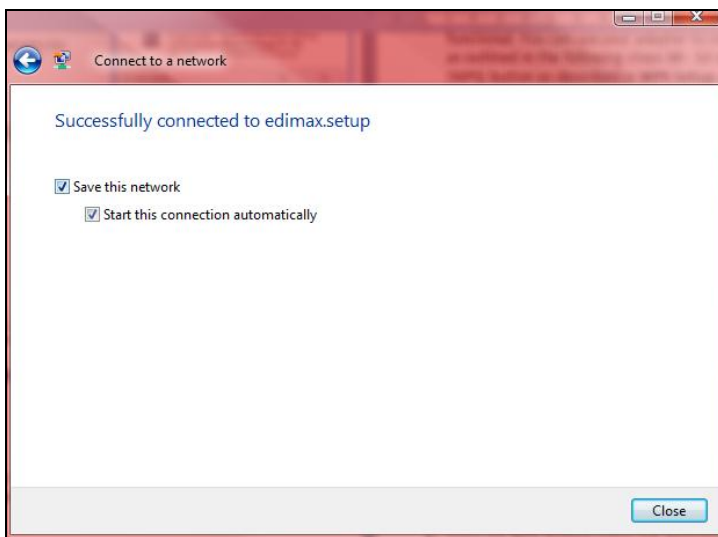
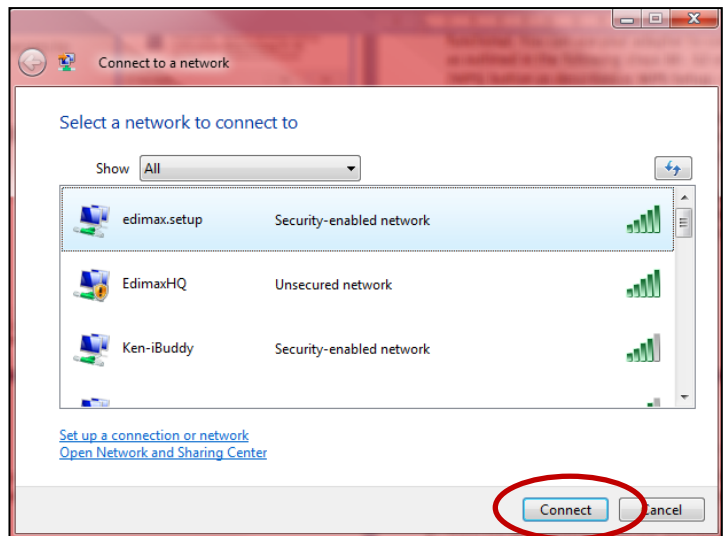
### Mac & Mobile Devices

View available Wi-Fi networks as usual for your device – on a Mac computer click the  icon along the top right of your screen.



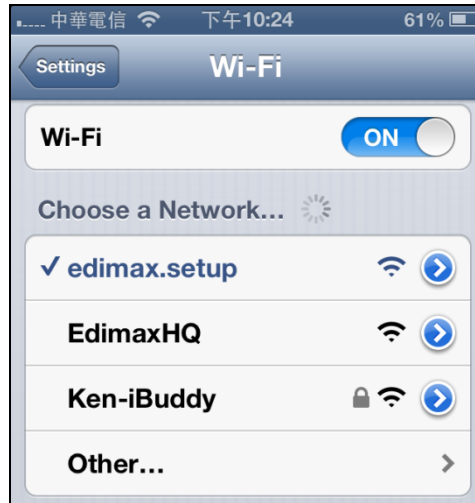
## 14. Windows

Search for the SSID which you named earlier and click “Connect”. If you set a password for your network, you will then be prompted to enter it. After entering your password, you will be successfully connected to the BR-6478AC’s Wi-Fi network.



## Mac & Mobile Devices

Click on the SSID of your network. If you set a password for your network, you will then be prompted to enter it. After correctly entering your password, you will be successfully connected to your Wi-Fi network.

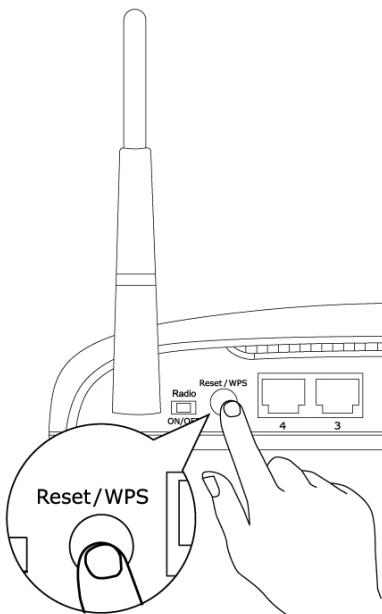


**Alternatively**, if your wireless device supports WPS, you can use the **WPS** button (see below).

## **WPS Setup**

---

If your wireless device supports WPS (Wi-Fi Protected Setup) then you can use this method to connect to the BR-6478AC's Wi-Fi networks.



- 1.** Press the **WPS button** on the router to activate WPS for both 2.4GHz and 5GHz.
- 2.** **Within two minutes**, press and hold the WPS button on the **wireless device/client** to activate its WPS.
- 3.** The devices will establish a connection. Whether the connection is 2.4GHz or 5GHz depends on the **wireless device/client**. Repeat for additional wireless devices.

**Note:** Please check the instructions for your wireless device for how long you need to hold down its WPS button to activate WPS.

# Troubleshooting

---

## 1. I can't access the Internet.

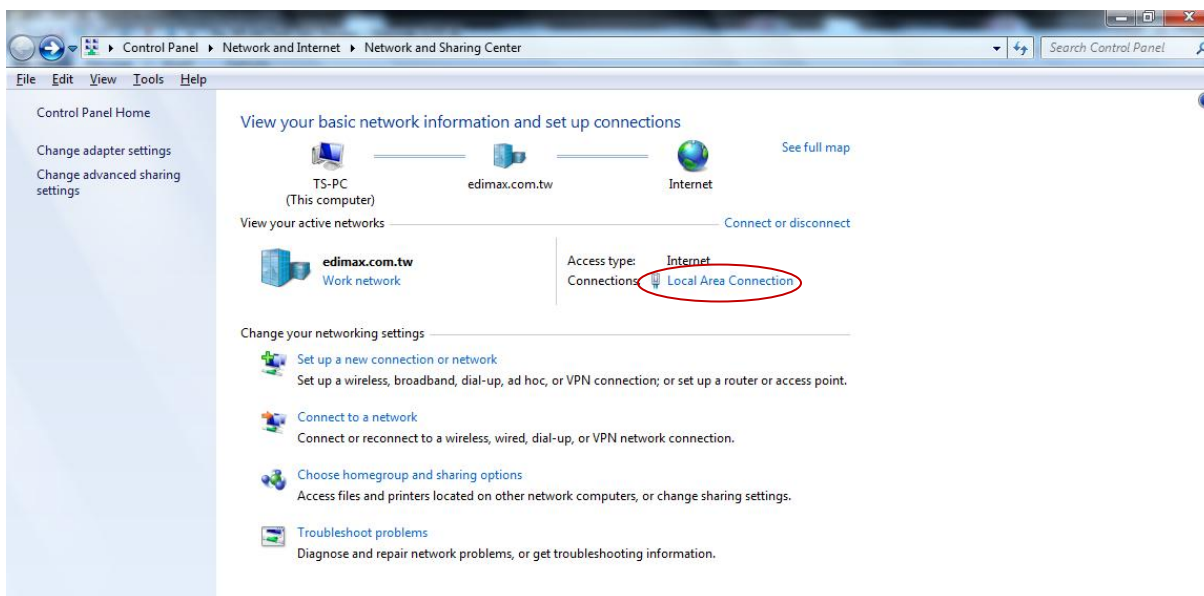
1. Ensure that all cables are connected properly. Try a different Ethernet cable.
2. Check if you can access the web based configuration interface. If not, please refer to **2. I can't open the web based configuration interface.**
3. Login to the web based configuration interface and go to **Internet > WAN Setup** and check that the connection type is correct. If you are unsure, please contact your Internet Service Provider (ISP).
4. Connect your computer directly to your modem and check if you can access the internet. If you can't, please contact your Internet service provider for assistance.

## 2. I can't open the web based configuration interface.

Please ensure your computer is set to use a dynamic IP address.

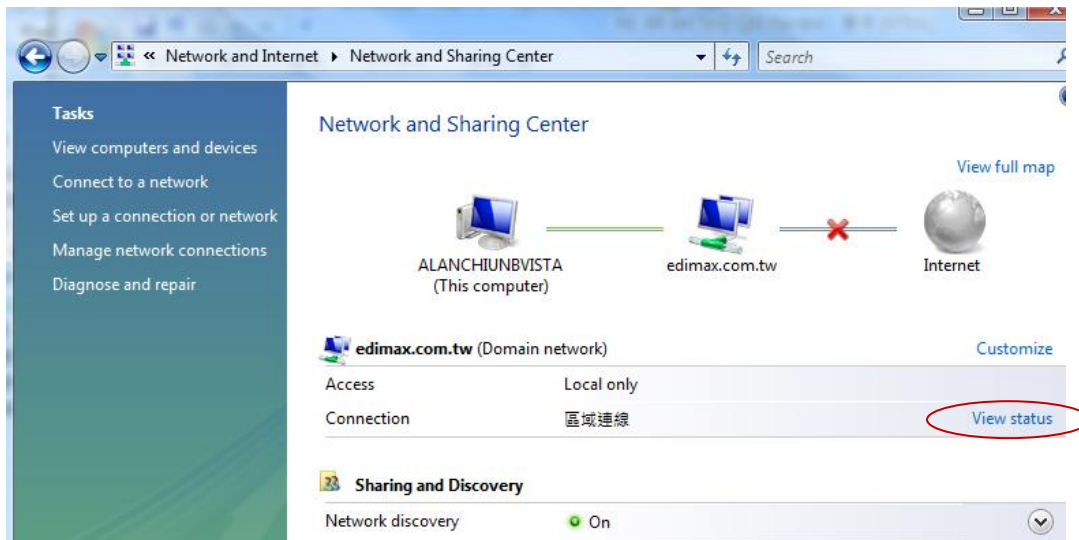
### For Windows 7:

Go to **Start > Control Panel**. Click **View network status and tasks > Local Area Connection > Properties** and double click **Internet Protocol Version 4 (TCP/IPv4)**. Select **Obtain an IP address automatically** and choose **Obtain DNS server address automatically** and click **OK**.



### For Windows Vista:

Go to **Start > Control Panel**. Click **View network status and tasks > View Status > Properties** and double click **Internet Protocol Version 4 (TCP/IPv4)**. Select **Obtain an IP address automatically** and choose **Obtain DNS server address automatically** and click **OK**.



### For Windows XP/2000:

Go to **Start > Control Panel**. Click **Network and Internet Connections > Network Connections**. Right click **Local Area Connection**, select **Properties** and double click **Internet Protocol (TCP/IP)**. Select **Obtain an IP address automatically** and choose **Obtain DNS server address automatically** and click **OK**.

### 3. How do I reset my router to factory default settings?

To reset the router back to its factory default settings, press and hold the WPS/Reset button for over 10 seconds, until the power LED begins to flash. When the router restarts, all settings will be reset.

### 4. I forgot my password.

Reset the router to its factory default settings and use the default username **admin** and default password **1234**.
